Functions of the Committee

1. Paste the posters published by the University and AICTE in all the public areas of the campus. Bring awareness among the students about the consequences of ragging on the campus.
2. To uphold and comply with the directions of the Hon'ble supreme court and be vigilant on any acts amounting to ragging.
3. To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging
4. To consider the complaints received from the students and conduct enquiry and submit a report to the Director along with punishment recommended for the offenders.
5. Anti-ragging committees/squads to make surprise visits and take effective steps to prevent ragging.
6. Oversee the procedure of obtaining undertaking from the students in accordance with the provisions. Conduct workshops against ragging menace and orient the students.
7. To provide students the information pertaining to contact address and telephone numbers of the person (s) identified to receive complaints/distress calls.
8. To offer services of counseling and create awareness to the students.
9. To take all necessary measures for prevention of ragging inside the campus/Hostels.
